

Notification

The Ministry of Food Processing Industries, Govt. of India has launched a new Centrally Sponsored Scheme for 'Formalization of Micro Food Processing Enterprises' across the country with an aim to modernize and enhance the competitiveness of existing individual micro-enterprises and to support new micro-enterprises/FPOs/SHGs/Cooperatives for creation of common infrastructure along the entire value chain. Punjab Agro Industries Corporation is designated as the 'State Nodal Agency' (SNA) to implement the scheme in Punjab.

In accordance with the institutional architecture of the Scheme, the Government of Punjab hereby constitutes District Level Committee (DLC) for approval of applications for loan and subsidy to individual micro enterprises; recommend applications for common infrastructure & groups to SNA; monitoring handholding support by District Resource Person etc. as provided in the scheme guidelines (to be sent through email). The composition of the Committee is as under:


